

Hi Pauline

Thank you for the message and really appreciate you trying to contact people in regard to the petition. I have known from the advertising that J Stirling has been working with the UK column for have seen his name there mentioned. However it is news to me that they are working with MP's, where again I will say it will do no good whatsoever.

The reason I say this is quite simple, where from the truth of eighteen years experience of my own unlawful malicious persecution. Plus the fact of now nearly three years of research on the net of reading individual cases of the same persecution on the net, the law, and government legislation and protocol.

Firstly under the law, and government legislation, any discussion on the law by any MP will deemed as unfit for purpose in Parliament. The reason being is that the clever MP's and their common purpose friends (judges solicitors and the police), were made by those truly in control (the idle rich like Rockefeller) (and I have letters from the PM and the shadow home secretary saying this) **Government legislation clearly states The Justice System (i.eThe law) has to remain separate from government to protect itself from government influence** Clever is it not, where any MP cannot bring up any law issues in parliament. **Secondly** there is a thing in government legislation, which is called strict parliamentary convention. This also prevents any MP from bring up many other issues in parliament, such as the wastage of tax payers money, solicitors fiddling the legal aid, MP's from fiddling their expenses, etc etc. Which is why when you couple this with the memorandum of understanding between police and law society, why do you think the MP's caught fiddling have not gone to jail. BECAUSE THIS IS WHAT GOVERNMENT HAVE WRITTEN INTO THEIR LEGISLATION. It is not law but is being used as such (although illegal as it goes against the human rights and civil liberties acts) Where this same unlawful legislation is being used to stop any of us from using the courts. Pauline you were there in court with others, when judge Hickinbottom made his statement "Mr Ronald it is a known fact that no government department of complaint works for the public" Why would this judge dare use such a statement if it was not true ?

You also must remember we the three of us all put this in our statements to the police, and have they arrested anyone, no ? Where from three years of reading the many other peoples issues and my own experiences, nobody has had any success in trying to change this in the last twenty years because it has all been done deliberate to take us into the EU. From my own experiences I have written to every single government department and many, many organisations and unbeknown to us, government legislation has been placed, to override the law, The reason being is it is all being done deliberate, to keep the people as slaves without the shackles.

Where one must remember all MP's are made to become freemasons or they are frozen out of office, by other freemasons.

This can be further shown of how when first going to solicitors Evans & Payne, I saw Richard Payne the junior partner. Where in Richard contacting my former solicitors with view to prosecution, he was induced by solicitor Nigel Jones to join the masons. Where in showing the unlawful protection they offer, (Remember his job was online her, plus heavy prison sentence for much malpractice, fraud and deception) Nigel Jones went out and using a false name, sexually assaulted six estate agents, and only gave himself up to police when his picture appeared on the news. He received six months and a five hundred pound fine, did six weeks (in open prison (like butlins) and was allowed back out to practice. Where his practice was prior Nigel Jones and Co he before going to police took in partners to keep his business open (again under the law fraud, deception and collusion) Senior partner James Evans of then Evans and Payne, then leaves the practice to work from home (the senior partner under the law is usually the one to stay in any disolvement of practice) and Richard Payne continually asks me (Taking the pi\*\*) if I was in the square or an upright person, which are signatories of mason's recognition signs.

Further to this are the many speeches statements I have read from the House of Lords, where many of the lords are constantly requesting to take the justice system further away from

government. The reason being quite simple, which is they cannot be arrested for making themselves unlawfully richer.

This can be shown quite literally with the man made projections of figures by finance companies, which keep being (deliberately) projected wrong. Where the public go out and finance themselves up to the hilt to buy their luxuries, such as expensive homes. The projections are then given in their correct form, which they say were projected wrong and the many, such as predicted in the news this week (330, 000) lose their homes as they cannot afford them. The rich then move in and buy up the property for around a third of its value. (There was an article in the news and on television of how the rich have become twice as rich in this recession) Plus one must remember when one has everything it can lead to many perversions, which they do not want exposed as they are all part of masons rituals. Does one not remember in the news of the disgraced MP who had an "I'm a fucking stinking rich party" where he was also quoted as saying many times to people, "if you get in my way I will crush you, crush you" (which again under the law is an abuse of power, by malfeasance in office)

Just look at the world wars and who financed them, Bushes grandfather financed the Germans, as well as eventually his own country. The Iraq war has made many, many, brethren of the government very, very rich, where when one goes into the boards of directors and affiliated companies just look at the names of directors or advisors that are in government ?

Let me explain it this way and you will see how government works against the people – Imagine if the whole of the UK, rose up peaceably in protest against the government, where they all go on strike and say we are doing no more until you uphold the law and stop your fiddling. The government would simply declare a state of martial law and put the troops on the streets. Why do you think they want to introduce road tolls, it is simply once we enter into the EU, the road tollbooths will be managed by troops. Where all name places disappear and we live in sectors, just as they did in Russia years ago, where they had to get permits to travel to each sector. For the EU is simply a one state communist regime where the all, work for the new state(i.e world government) (Where the rich get richer and the people remain as slaves without the shackles)

To further show this statement just have a look at how many now very, very rich Russians were connected then to the KGB (polibuiterro)

Where again the rich will be able to move their finances around to become richer, which is what they are secretly doing now and deliberately causing all the recessions.

This again can be shown by the false projected figures of the insurance companies for when the many lost their pensions on badly protected figures, who got charged with any fraud and deception ? Because under the law that is what it is.

What one further has to remember is that freemasonry like religion is all a con, it is there to keep the rich (and I mean those with billions) and in complete power. did, and even now feel such a fool for believing it. I further explained to you of when I had a go at Nadia for placing that stupid petition, I say stupid because if she had done her research, she would have found out, that due to the ever rising figures of unlawfully persecuted, the government continually change the names of all departments, which they did two months after she started the petition. Where any figures gained would have only been referred to as any complaint, sorry that was under the old regime this is now new, so any petition, just like any other case, would be, that was then, this is now. Which is another classic example of how the government unlawfully use legislation to override law ? Further to this it gives information back to the government which they then use legislation, to block any other law abiding attempts to stop the rot. Remember they continually feed off our attempts to stop this unlawful persecution, which is why nothing so far has been achieved. Where one further has to ask oneself this, if she got herself unlawfully incarcerated for several months, under the restraint orders she already has placed against her, she could further be made a vexatious litigant, or if one of the people she is restrained from approaching lies to do this, what would happen to her mother ? Also one must ask what would happen to her ? Where on anyones release from jail any attempt to try and maintain truth would result in, she is lying she is a convicted criminal, where any statements no matter how true would not be believed. Research forethought and knowledge is the only thing that will bring this to an end, not stupid acts or hope ?

There are of course, as we know the many out there who pretend to help, and from what you and I know of personal experience they are just there for their own gain. There are also others who even if the litigation side is sorted for the many may not have their own persecution sorted, so they do not want it to end, as there will be less numbers to fight. Where I know from many years experience in thinking I was alone, it is frightening. We also are all human and the many believe their way is the only way, and they rather than read books such as Zen and the art of motorcycle maintenance, become very staid and stubborn in their ways. This can be further shown of how I have been ostracised from the rest in regard to my comments of Nadia. Where each and all believe theirs is the stubborn right way and they will not make or accept change, and again noe like the truth when it hurts. Of course it has to be said again, one also has to take into account the many that are pretending to work with us and have ulterior motives. Where they do not want these unlawful malicious circumstances to end, due to their own selfish ulterior motives.

Why do you think I have researched so hard and for so long into this and found the only lawful way in which we can get justice ? Where in six months the Queen under EU rules forfeits the sovereign protectorship and we have no lawful redress ? Except that is through the EU courts which by the time they use legislation as further delaying tactics will take up and maybe over ten years ? Remember I recently informed you that Britain has quietly and secretly pulled out of it's agreement on Crime against humanity, which would be heard in the Hague. This is because, and one of the reasons I had a go at Nadia, information is constantly being gathered on us all. Which can be used at any time to get to us, such as you know yourself unlawful sectioning. Where under the new EU rules, we will all apply on screaming in regard to injustice and many other issues, be noted for crimes against the state, which is jail time.
